



LAKE DUNSTAN REGATTA 5TH & 6TH DECEMBER 2015 REGATTA CONDITIONS

Racing will be over two days with heats for most events on Saturday and finals on Sunday. Owing to low entry numbers in open events, coxed fours and eights, these events are straight finals on one day only. Crews must row in Saturdays heats to be drawn in Sundays finals.

The qualifying date for all age group events is **1 January 2016**, ie athletes must be under the age on that date.

All events are over a 2000 metre course, except Masters and President's events and Nov Doubles which will rowed over 1000m.

Master's fours/quads may be coxed or coxless, an 8 second penalty will be applied to coxless boats.

All events shall be rowed under the rules of the S.R.A and N.Z.R.A. All events which are sanctioned by the Southland Rowing Association are to be run in accordance with the Rowing New Zealand Rules of Racing 2013.

All requests from the Chief Umpire with regards to the safety of participants must be adhered to.

The Chief Umpire reserves the right to postpone, delay or cancel the regatta at any time if concerns for the safety of any regatta participant exist.

All coxswains must wear lifejackets.

Any events with more than nine starters will be rowed in divisions.

Alpha Numeric Lane numbers must be used and are to be supplied by the regatta organiser.

Lane number one is closest to the starter. All events start strictly at the advertised time. No crews will be waited for. Crews should be within the starting area 5 min before the advertised start time.

All scratchings must be given to the regatta secretary no later than 1 hour before the advertised start time of the event.

Club captains of all clubs are to attend a meeting at 7:15am upstairs in the Dunstan Arm Rowing Club.

Crews must proceed to the start inside lane one, on the pavilion side of the course. Any crew missing the start must row down the outside of the course.

Clubs must ensure skiffs are in a safe condition and must make them available to an umpire for inspection if required. Any skiff deemed unsafe by the umpire may not be used until the fault has been rectified and the skiff has been passed as safe by the umpire.

Crews are reminded that at the finish, all skiffs must remain parallel to the course until the race umpire has cleared the race.

The entry fee for this regatta is \$3.00 (incl GST) per seat excluding coxswains.

President's Grade: This grade has been introduced to cater for those rowers who though low training volume or experience choose not to row in other events. A rower competing in Presidents Grade is not eligible to row in another grade, excluding Master's events, at the same regatta. Clubs are encouraged to apply discretion when entering this grade which is designed to cater for recreational rowers who wish to compete in regattas.
