- Entry Fees are \$4.50 per seat + GST. Fees are to be direct credited to the bank account detailed on page 2. Please clearly include your club/school reference details in the payment.
- Entries open Monday 30 September 2019 and will close at 10.00pm Friday 18 October 2019.
- All regatta entries must be made online using the rowIT entry system. Instructions for using this system are set out on page 3.
- If you require ease of identification and clarity of Clubs/Schools entries for billing seat fees then Clubs/Schools should enter under their own rowIT code. Normal club affiliation will apply for calculation of Club regatta points for the Millennium Cup. School Crews have the option of racing in either Club or School colours. Schools entering the regatta will be identified with their rowIT entry code. (see page 4 for more detail). Unique school identification is important for Takapuna Cups trophy points accumulation.
- Coxswains weights are to be 55kg for all events. Crews are responsible for their own weights. Spot checks will be made by the ARA Representative following races. Crews with underweight coxswains will be disqualified.
- Tent sites are restricted at Pupuke. There will be four 'premium' sites (6m x 8m) available with unrestricted water views. Cost of these sites is \$150 plus GST. These premium sites are limited and will be allocated on a "first received" basis. If you wish to reserve one of these then please indicate so on the entry form and include a separate payment. This payment will be refunded if you are unsuccessful.
- PLEASE NOTE bow numbers, based on an alpha numeric system, will be available from the Secretary's caravan, and **MUST** be used to identify crews for each race.

Both Waitemata and Takapuna look forward to seeing you and your supporters at this regatta.

All Auckland Clubs and Schools already have rowIT logins. You should contact Andrew Carr-Smith if your logins need updating and to make sure you have the set-up that suits your club or school.

As this is still the start of a new Season clubs may need to update their Roster before making entries.

- Rowers who have been entered in regattas previously are already recorded in the rowIT database.
- All new rowers must be in the rowIT system before you make your entries.

You can either add new rowers directly to the rowIT database. Or you can now add them to the RNZ database as <u>unlicensed or licensed</u> members of your club or school and then import them into rowIT.

For ease of identification of Clubs/Schools and clarity in billing seat fees we request Clubs/Schools enter under their own rowIT code. School crews that are entered under a club's code should use double-digit crew numbers for identification.

rowIT has the ability to provide <u>dual recognition of both club and school</u>. This can be used to supplement the identification of schools using one of the above methods. It is done during entries by recording both school and club for a crew. Details have been provided to rowIT logins holder by Andrew

Crew numbers will be used for seeding crews into divisions. If you are using double-digit crew numbers the second digit is the important one. If you have a crew that is your only entry in an event but you wish to row it in an easier division (ability reasons only please!) then allocate a higher crew number e.g. AKLC 2, WESC 22, etc.

Composite Crews may be entered through rowIT. This is achieved by linking with another entity and bringing their athletes into your squad (then selecting a crew mix of those athletes and your own athletes). Composite crews will be identified as belonging to the entity that enters the crew e.g. a crew entered by North Shore will be a north Shore composite.

Entries Crews will be able to be entered into the rowIT regatta entry system from Monday 30 September 2019 until 10.00pm Friday 18 October 2019.

Changes Scratchings, late entries* and substitutions can be made, via the rowIT program, from about lunchtime Monday 21 October up to Thursday 24 October.

* Late entries will only be accepted if there is space in the program, and it does not increase the number of races.

Day sheet We will endeavour to provide Clubs with a day sheet early in the week before the regatta so you can check your entries.

Tent sites Requests should be sent direct to the Regatta Secretary and these will be allocated outside the rowIT regatta entry system.

Notes:

- 1. Senior and open events have been combined for this regatta.
- 2. The Men and Women open eights will row with a handicap in the club eight events.
- 3. Please note that we may combine U18/Club events in the event of low entries in a specific event. The only exceptions being the U18 and Club quad races.

Conditions of Entry

- 1. Events rowed under the NZRA Rules of Racing and Directives for Regattas with special conditions by the ARA.
- 2. Events rowed on approximately 1000m course.
- 3. No. 1 lane position nearest the starter.
- 4. Boats to be identified by fixed alpha numeric bow numbers supplied by the regatta organisers. Boats without a bow number may not be allowed to start.

NOTE: Boat numbers will be supplied by the ARA from the Secretary's caravan.

- Coxswain weight 55kg for all events. Crews are responsible for their own weights. Spot checks will be made by the ARA Representative following races. Crews with underweight coxswains will be disqualified.
- 6. Bow balls must be the correct size and correctly attached.
- 7. Coxswains must wear a New Zealand Safety Standard approved lifejacket.
- 8. Heel restraints must have a maximum 70mm free movement. All boat shoes must be fitted with a quick release mechanism Velcro, or similar. Lace-up shoes will not be permitted.
- 9. For bow-coxed boxed boats there must be an exit facility for coxes.
- 10. Programme alterations may be made to suit the day's weather conditions.
- 11. Umpires and starters may combine races at their discretion.
- 12. Late entries accepted only where numbers permit. Payment must accompany late entries otherwise the crew will not be allowed to start.
- 13. Crews must finish outside the marked buoy anchored close to the finish. Failure to do so may result in disqualification.
- 14. The ARA will mediate any disputes that will arise, and their decision will be binding.
- 15. The ARA will mediate the refunds if the regatta is cancelled. All clubs must pay the entry fees prior to race day.
- 16. The safety meeting held prior to the start of the regatta is compulsory for all club/school reps to attend, and those that do not attend will not be allowed to race until they have received instruction from the officials.
- 17. All coaches will be required to attend a compulsory safety meeting at 7.15 am on the grass bank in front of the marquees.

IMPORTANT MESSAGE FOR CLUBS

- 1. Only vehicles towing boats and official cars with a parking pass will be allowed entry to the car park. Disabled parking will be available.
- 2. Buses are not permitted in the Park of Sylvan Park Avenue. Please advise buses of this restriction.
- 3. Parking has been restricted in Sylvan Park Avenue as a condition of use of the reserve. Please observe the requests of the regatta marshals.
- 4. Regatta traffic is not permitted into the cul-de-sac past the park gates.
- 5. Auckland Council has advised that vehicles parked on verges or in no parking zones around the Lake will be towed away. Please advise your Club Members as Auckland Council has advised parking restrictions will be actively policed at all Lake Pupuke regattas.
- 6. Refer to the Regatta Booklet published by the ARA for the 2013/2014 season for details of the Lake Pupuke venue.
